- All payments are NON-REFUNDABLE and can be made by EFT only. Please confirm availability for your dates with me via email before making any payments.*
- The outstanding balance of the fee should be paid on the FIRST day of the month of your wedding. Please use your name and date of the event as reference.*
- Once you have accepted the quote and payment has been made, no deductions can be made from there on forward.*
- Add-ons to the quote must be made 1-3 weeks prior to the wedding date.*
- Please note that the client will be responsible for any international transfer fees and will not be on the account*
- of Estelle Pretorius Make-up Artistry. Cash payments may be subject to additional administration fee in order to cover bank charges.*
- Cancellation of the invoice requires 4 months notice, failing to do so you will be held liable for the full amount of the invoice and will immediately become due and payable.*
- Postponement of wedding date / invoice in the event of a force majeure or a consequence thereof e.g. a Pandemic and/or resultant Government intervention (Lock-down), will attract no penalties or additional costs, provided that a new, mutually available date is agreed upon by the contradicting parties. Estelle Pretorius Makeup Artistry should be provided*
- with at least 3 possible new dates, within 7 days notice in the case of postponement. Should Estelle Pretorius Makeup Artistry not have availability for any of the 3 (three) proposed dates, the client will receive a full refund of their 50% deposit.*
- Postponement of wedding date/ invoice within 4 months of the date of the wedding will attract additional cost/ penalty fees.*
- Estelle Pretorius Make-up Artistry & Hair Styling and assistants cannot be held responsible leading up to and on the day of the wedding in the event of unforeseen circumstance, such as load-shedding, roadworks, accidents, car failure, medical emergencies or force majeure.*
- If the bridal party should consist of 4 or more members, I will be assisted by a professional qualified assistant. Should an assistant be needed for the day of the wedding, an additional traveling fee for the assistant can be added to the invoice up to 2 weeks before the wedding.*
